**PRICING CHART for AAFCO Check Sample Program part-year participation (2010)**

Participants that enroll in the Program or renew their subscription later than April 2010 will no longer be able to pay for the complete year subscription and receive all the samples that they have missed. The cost to participate for the rest of the 2010 year will be determined by the number of months remaining. For US or Canadian participants the cost is \$21.25 per month and for international participants the cost is \$25.00 per month. Participants will pre-pay for the remaining 2010 samples as appropriate. Please use the chart provided below to determine your cost to participate starting in a given month. If you are sending in your invoice form later than the last day of the month that a sample will ship, you will be able to participate starting with the next monthly sample. For example, if you send in your invoice between July 1<sup>st</sup> and July 31<sup>st</sup> the earliest sample that will be shipped to you is 2010-28 (results due September 10<sup>th</sup> 2010). You would need to pay \$106.25 (domestic or Canadian labs) or \$125.00 (international labs).
